

MADRASAH FEES & METHOD OF PAYMENT

Academic year at Madni Madrasah commences during first week of September and ends at the end of following August. Following fees / costs are payable by each student;

1. **Assessment Fee:** **£10 per student** - From 01 September 2021 (Currently free)
2. **Registration Fee:** ~~£20.00~~ (Registration fee has been waived during COVID 19 until further notice) who is offered a place in Madrasah following successful assessment. This applies to both classroom based and online students.
3. **Cost of Books:** Cost depends on allocated class / number of books. Details will be provided after the assessment. Payable at registration.
4. **Annual Tuition Fee:** **£280 per student for weekday Madrasah** From 01 September 2020, the Madrasah tuition fee has been set at £280 per student per annum. *(for both classroom-based as well as online lessons, including Hifz class)*
5. **Annual Tuition Fee:** **£180 per student for weekend Madrasah** From 01 September 2020, the Madrasah tuition fee has been set at £200 per student per annum. *(for both classroom-based as well as online lessons)*

Cashless Payment Only

Since April 2020, Madni Madrasah no longer accepts cash payments.

All payments to Madrasah must be made into Madrasah bank account. (bank details on page-3 below)

All applicants must select their preferred method of payment they would like to use from the 06 methods shown below. These cover both weekday as well as Weekend Madrasah.
