



## COVID-19 Liability Waiver/Disclaimer

ICEA is pleased to be able to open Madni Madrasah following the physical closure in March 2020 due to COVID-19. ICEA has conducted a thorough COVID-19 risk assessment and is implementing new processes in light of the pandemic.

In consideration of being allowed to return to Madni Madrasah, I, Parent or Guardian of the child in section-3 of the registration form understand, acknowledge and agree to the following:

1. I certify that my child is physically fit to attend the Madrasah in person and have not been advised otherwise by a qualified medical professional.
2. I agree to comply and to brief my child to comply with any and all new rules, regulations, terms and conditions including but not limited to cleaning of hands, refraining from shaking hands, keeping safe distance from others and not bringing any food items to the Madrasah.
3. COVID-19: The coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is contagious and is believed to spread mainly from person-to-person contact. It is believed that an individual can be infected with COVID-19 without their knowledge and be asymptomatic.
4. Madni Madrasah has put in place preventative measures to reduce the spread of COVID-19. However, Madrasah cannot guarantee that I, my child or anyone else will not become infected with COVID-19, including people in my household.
5. I UNDERSTAND AND VOLUNTARILY ACCEPT AND ASSUME ALL the foregoing risks related to COVID-19 and accept sole responsibility for any injury or illness that may occur. Further, I UNDERSTAND AND AGREE that this release includes any claims based on the actions, omissions, or negligence of ICEA Madni Madrasah, & its employees, whether a COVID-19 infection occurs before, during, or after participation in any Madrasah lessons or visit to ICEA premises.
6. If I or anyone in my household presents COVID-19 symptoms, or I am contacted by the Test and Trace service, I will inform Madni Madrasah administrator as soon as possible and will not send the child to Madrasah, and I will then isolate as advised by the UK government and professional medical services.

I further acknowledge that ICEA cannot guarantee that a child or parent will not become infected with the Coronavirus/Covid-19 whilst using its premises. I understand that the risk of becoming exposed to and/or infected by the Coronavirus/COVID-19 may result from the actions, omissions, or negligence of parents, children, others, including but not limited to, ICEA staff, worshippers, contractors and other visitors attending ICEA premises.

I confirm that in relation to child’s Madrasah affairs, and in particular when dropping off or collecting the child, I or anyone else on my behalf;

- a) Will not enter ICEA premises if experiencing any symptom of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- b) Will not enter ICEA premises if returned from abroad within the last 14 days.
- c) Will not enter ICEA premises or send the child to ICEA premises if I have been exposed to someone with a suspected and/or confirmed case of the Coronavirus/COVID-19.
- d) Will not enter ICEA premises if I’m waiting for result of COVID test.
- e) Am following all govt recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID-19.
